#### **MEETING CALLED TO ORDER**

- Tammy Ozier opened the meeting at 1:00 pm and welcomed members and visitors.
- Tammy also reminded all attendees to join and/or to renew their membership. The
  requirements for joining were shared, including required membership with AAHGS National.
- Tammy Ozier introduced the program format for today's meeting.

#### MEETING PRESENTATION

Janice Bryant introduced the speaker, Akosua Moore. Ms. Moore researches her family history along with others in the Lowcountry. Currently she is contracted with a firm to provide genealogical services to the United States Army and research through her company, TheKinSeeker, LLC.

Speaker: Akosua Moore presented Speaking of My People: A Granddaughter's Journey Into the Lives of her Lowcountry Ancestors. The speaker presented a review of her family history and included resources and sources for her findings, including:

- NARA Research in search of pension files
- Fold3 USCT records
- Freedmen's Bank
- Freedmen's Bureau records
